Special Meeting of the City Council
March 9th, 2026

The City of Terrytown Council met on Thursday, March 9th, 2026, at 6:00 PM, for a regular meeting of the City Council at the Community Room in the Carpenter Center, 116 Terry Blvd in the City of Terrytown, Nebraska. Notice of said meeting was published in the Star-Herald according to Nebraska State Law and posted in the following three prominent places 89A Woodley Park Road, 116 Terry Blvd, and 120 Terry Blvd as outlined by ordinance. Mayor, Chris Perales called the meeting to order at 6:02 p.m. Council Members present in person were Tyler Feil, Mike Minzey, and Emily Norman. City Clerk, Jeni Matten was present and took minutes.

The Pledge of Allegiance was recited by those in attendance. Mayor Perales pointed out the location of the poster for the Open Meetings Act.

Janelle Visser, Panhandle Public Health District spoke to the council regarding painting crosswalks in Terrytown. She showed the council pictures of other community's crosswalks. She talked about communication with Minzey through Tri-City Active Living. She explained how the Safe For Steets (S4S) grant opportunity came about and discussed community connections. Norman moved to move forward with the S4S Crosswalk project. Minzey seconded the motion. Aye's: Feil, Minzey, and Norman. Nay's: none. Motion carried.

Visser said she looked at the proposed locations, and all appear to be ADA compliant and therefore meets the requirements. Feil asked about the painted crosswalks possibly connecting the Monument Pathway. Visser mentioned that we could look at signs as well. Visser stated that she has budgeted about \$2000 so about \$500 per crosswalk. Perales mentioned the one on Woodley Park to consider moving closer to the park. It was moved by Norman to determine exact locations at the April meeting to give everyone the opportunity to look at the proposed locations. Minzey seconded the motion. Aye's: Minzey, Norman, and Feil. Nay's: none. Motion carried.

Michael Marquez, Terrytown Resident, was present at the meeting. Marquez designed and painted the murals at Hascall Park in 2025. Mattern requested he be at the meeting with potential for him to design the crosswalks. Feil moved to approve Marquez designing the crosswalks. Norman seconded the motion. Aye's: Norman, Feil, and Minzey. Nay's: none. Motion carried.

Marquez will come to the April meeting with plans and what he would like to be paid. Norman suggested he come up with a couple of ideas, and we do a Facebook pole.

Minzey moved to approve the minutes from the February 12th, 2026, Regular Meeting. Norman seconded the motion. Aye's: Feil, Minzey, and Norman. Nay's: none. Motion carried.

At 6:34 p.m. Feil moved to adjourn. Minzey seconded the motion. Aye's: Minzey, Norman, and Feil. Nay's: none. Motion carried.
